Implementing Allowable Activities

READ Act funds will be used to purchase Barton tutoring. Trained tutors within BVSD will deliver services for students on READ Plans both after school and in the summer months.

READ Act funds will be used to provide other targeted, evidence-based or scientifically based intervention services. READ funds will be used to hire a reading interventionist to provide services which are approved by the department. One interventionist at one elementary school will deliver scientifically based intervention to K-3 students on READ plans during the school day. READ funds will pay for the portion of her salary to cover her time with these students.

READ Act funds will be used to provide technology included on the Advisory List of instructional programming. READ funds will be use to purchase iReady and iStation benchmark assessments as well as iReady instruction.

READ Act funds will be used to supplement core instructional materials with Fundations which is on the supplementary materials approved list. Currently, BVSD has FPC as the core. In order to address foundational skills in reading we will use Fundations to supplement.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Providing additional training in scientifically based reading instruction will enable more educators to deliver this instruction to students both during the school day and in after school tutoring. Combined with Fundations at K-2, we will close the reading achievement gap for the majority of students falling well below grade level. By the end of the 2020-2021 school year, our goal is to have 85% of students currently reading below grade level reach grade level standards in reading. We know it is a lofty goal given the number of students on READ plans.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

Many teachers are not trained in scientifically based reading instruction. We plan to provide this professional development so teachers have the tools and knowledge they need. Many students reading below grade level have the characteristics of dyslexia however, we have not identified these students, and often do not give them the intervention they need. BVSD will implement a pilot dyslexia screener to identify those students needing OG based intervention. Many students who have difficulty with decoding get flagged as having comprehension gaps and they get put in a comprehension based intervention. BVSD is currently revising its process for intervention placement so students get the intervention needed to address their specific needs.
