 - Provides explicit and systematic skill development in phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension and;
 - Includes scientifically based and reliable assessments and;
 - Provides initial and ongoing analysis of student progress in attaining reading competency

READ Act funds will be used to purchase a core reading instructional program that is included on the Advisory List of instructional programming in reading

- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

READ Act funds will be used to provide other targeted, evidence-based or scientifically based intervention services to students who are receiving instructional services, which services are approved by the department

READ funds will be used to hire a reading interventionist to provide services which are approved by the department

1.0 full time teacher will use small group, approved, targeted, evidence-based intervention services to students formally identified with an SRD. These interventions will occur at least four times weekly, and regular progress monitoring will be conducted in order to inform instruction. The intervention teacher will collaborate with regular classroom teachers in order to share data, align instruction, and provide intervention specific strategies.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Through these small-group literacy intervention sessions, students will be given extra time and more individualized attention in order to target specific skills in which they need additional instruction, support, and practice. The literacy intervention teacher is trained in approved, evidence-based literacy intervention strategies and can work together with regular classroom teachers in order to reinforce skills already being taught and share literacy instruction and research knowledge/strategies. The expected outcome/goal for this activity is appropriate and measurable literacy growth for these struggling students.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

The primary potential barrier in reaching these goals will be group size. Just as in many Colorado elementary schools, the number of students identified with an SRD has been a challenge. Allowing time for regular planning and collaboration between interventionists and classroom teachers should strengthen instruction on both

fronts. Strategies can be adjusted in a timely manner, making overcoming this barrier more likely.
