CCSD will provide a half time reading interventionist to work with students K-3 who score below the 5th percentile on 2 out of 3 assessments (DIBELS, MWEA, STAR Early Literacy). This interventionist provides individualized reading instruction for students and monitors their progress.

Our goal is through interventionists and best first instruction our students continually improve in their reading ability ultimate achieving grade level competency. We expect a decrease in the number of student identified as having a SRD.

Given the shift to remote learning and the yet to be determined start of school this fall, we anticipate challenges assessments of reading skills and reading abilities. Further, spring instruction shifted to remote learning model with out deep planning and preparation, therefore we know students lost important instruction. We continue to improve with our distant and remote learning instruction strategies. As we prepare to return this fall we will have to be creative about how to recapture students learning.
