The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

Cheyenne Mountain School District has a staffing formula which includes Learning Interventionists at each of our elementary schools to provide targeted, researched based instruction to students on READ and MTSS plans. The role of the Interventionist is to provide individual and small group instruction for students who have a significant reading deficiency and assist them to become on level readers. Early intervention in grades K-3 (READ) is the primary focus for these interventionists; however, students in grades 4 - 6 (MTSS) are also supported if needed. READ funds support salary and benefits for one of the five interventionists.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Cheyenne Mountain's goal is to have all students reading on grade level by the end of 3rd grade, or sooner if possible. We have had strong results with the use of these targeted interventions with students at the elementary level. In almost every situation, the only students who are not reading on grade level upon exiting elementary school require an Individualized Education Plan (IEP).

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

This year one of our potential barriers will be face to face instruction. Due to COVID-19 if we are required to provide instruction remotely, or on a differentiated schedule, reading will have to be a priority to maintain closing of the achievement gap. We have plans in place for small group face to face assessment and team building.

We also will have our interventionist provide targeted intervention one-to-one remotely.
