  - Includes scientifically based and reliable assessments and;
  - Provides initial and ongoing analysis of student progress in attaining reading competency

**READ Act funds will be used to purchase a core reading instructional program that is included on the Advisory List of instructional programming in reading**

- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

**READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills**

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

READ Act funds will be used to provide other targeted, evidence-based or scientifically based intervention services to students who are receiving instructional services, which services are approved by the department

READ funds will be used to hire a reading interventionist to provide services which are approved by the department

Our overarching goal for paying the salary of a reading interventionist is to ensure that students who need an extra level of support are receiving it in the form of targeted instruction from a reading expert. Each student has an individual reading goal based on the specific component(s) that they have shown a deficit in. This person works closely with the classroom teachers to continually monitor each student's progress toward their individual goals.

## Potential Barriers

One potential barrier this year is going to be time that each student is taught by an interventionist. We are working on creating multiple schedule scenarios that would allow us to provide the resources that students need to close their learning gaps and actively access the grade level curriculum.
