

Implementing Allowable Activities

Our Read Act funding will provide for two important program components to help accelerate student achievement: a 3-week summer school program for elementary students in Grades K - 3, as well as providing an instructional coach for teachers in Kindergarten to 3rd grade. Instructional coach activities include job-embedded learning such as: individual coaching, modeling lessons, observation/feedback, and facilitating Professional Learning Communities. The instructional coach was hired through an interview process. Qualifications included: ESSA guidelines for an experienced, K-6 endorsed educator, knowledgable in DIBELS assessment, and a record of high student growth and achievement. The instructional coach has received additional training in research-based instructional programs - Heggerty, SIPPS, and Take Flight - to ensure strong depth of knowledge and skill set in the five components of reading.

The summer school program uses a research-based curriculum (Wonders 2017) to teach foundational reading skills to students at the Intensive and Strategic levels based on DIBELS end-of-year assessments. Students scoring at a strategic level are invited as space allows. Ellicott Elementary teachers use the core curriculum, as well as decodable and leveled readers, to teach phonics, phonemic awareness, and fluency skills. Students also receive instruction using Heggerty phonemic awareness curriculum, which has been approved by the state as a supplemental program.

Our instructional coach works specifically with Kindergarten - 3rd grade teachers to deepen knowledge of best, first instruction in the five components of reading. Teachers meet weekly in Professional Learning Communities facilitated by the reading coach, and dive deeper into DIBELS progress monitoring or best practices, followed up by regular observation and feedback, leading to a cycle of continuous improvement.

#### **Outcomes and Goals**

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Ellicott Elementary students will increase the percentage of students scoring at "Typical" or above on the Pathways to Progress to 75% at each grade level, K -

3rd.

Baseline data includes: Kindergarten - 55% of students met "Typical" pathway above for the midyear DIBELS testing, 1st grade: 60%, 2nd grade: 40%, 3rd grade: 60%. This will increase our overall effectiveness in increasing early literacy skills and closing the gap for struggling readers.

For our summer school program, individual progress will measured using the spring DIBELS composite score as a baseline. Our goal is that each student will show an increase in the composite score after participating in the 3-week program.

### **Potential Barriers**

# What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

One potential barrier to summer school is attendance. This is being addressed in the following ways: summer school will be held almost immediately following school vacation, with one week of break in between. The district will provide transportation, and free breakfast and lunches to students. Teachers will present parents with the option of summer school and discuss benefits by March at the latest so families are able to plan ahead for attendance.

Another potential barrier is the history of high turnover in staff at Ellicott Elementary. This has led to a lack of knowledge in best, first instruction in the 5 components of reading. This will be addressed by: weekly PLCs that discuss students' progress monitoring based on the 5 components of reading, ongoing, individual coaching, modeling lessons, and observation/feedback to ensure best practices are being implemented in each classroom.
