 - Provides initial and ongoing analysis of student progress in attaining reading competency

- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

Our district Significant Reading Deficient (SRD) population is typically at 30% at the beginning of the year. Through data analysis and review, we have determined that the use of a reading coach to train, guide and support classroom teachers our SRD population decreases by 10% by the end of year data collection. Our district experiences summer mobility and consistently finds us at 30% Reading Deficient at the beginning of the year again. We will use our READ Act funds to provide professional development programming to support educators in teaching reading by hiring a reading coach who is trained in scientifically and evidenced based practices in reading.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Our Significant Reading Deficient population will decrease by 20% by the end of year data collection with the guidance and training provided by a reading coach trained in scientifically and evidence based practices in reading.

Potential Barriers

The mobility of students is a potential barrier to reaching our expected outcome. By employing a reading coach to quickly assess and address the needs of each student, we will be able to more quickly devise and implement a learning plan that is guided and directed for the individual needs of each student quickly and efficiently. The continued support of the Reading Coach will ensure the academic support and success for our intervention program.
