- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

Our district is investing in a new K-5 English Language Arts curriculum for the 2020-2021 school year. Our Board of Education has approved the Amplify-CKLA curriculum, which has recently been placed on the Advisory List of Instructional Programming (2020) for grades K-3.

Outcomes and Goals

We expect to begin to see greater student gains in acquiring necessary reading skills with the implementation of a new curriculum that is based on research and evidence. This curriculum, along with the mandated K-3 Teacher Evidence-Based Reading Training, should help our students advance their abilities in reading.

Switching over to a new curriculum is always a challenge. Our staff will need to master the use of the new curriculum and our students will need to become comfortable with new formats and possibly new academic vocabulary with the new curriculum. To that end, our district's instructional coach has made this new curriculum a priority for our staff's professional development for the 2020-2021 year and she has committed to supporting our teachers especially in the first year of implementing this new curriculum.
