- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

READ Act funds are split proportionally between the two elementary schools in East Grand School District. The funds are used to pay for two reading interventionists who provide instruction using Yoshimoto Orton-Gillingham for students on READ plans.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Through the use of Yoshimoto Orton-Gillingham as the primary intervention for students on READ plans, the goal is to move those students from RED on DIBELS to YELLOW or GREEN. Red on DIBELS indicates a significant reading deficiency while yellow or green indicates slightly below grade level or at grade level.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

Currently, all primary elementary school teachers in East Grand School District are trained in Yoshimoto Orton-Gillingham. Students receive whole class instruction in this model and intensive instruction used as remediation for students on Read plans. The greatest barrier to reaching our goal is time. All students who are RED on DIBELS at the start of the year in the primary grades, receive intensive intervention using Orton-Gillingham. The further behind a student is, the more time they need to get caught up and the more intensive the intervention needs to be. East Grand School District has worked to provide this time by hiring additional reading interventionists (not paid for by these funds) to help support this need for time.
