Implementing Allowable Activities

At the Bayfield Primary School, READ funds will pay for the partial FTE of three interventionists, one in grade K, 1, and 2, who will provide 30-minute intervention sessions for students with Significant Reading Deficiencies. Students will be served in small groups not larger than 5 depending age and intensity of need. Teachers provide intervention sessions in addition to a student's universal reading instruction in the regular classroom.

At the Bayfield Intermediate School, READ funds will pay for the partial FTE of one interventionist in grade 3 who will provide 30-minute intervention sessions for students with Significant Reading Deficiencies. Groups of students in each session will not exceed 6.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Under normal circumstances, our expectation would be that all students with a Significant Reading Deficiency would make catch up growth as evidenced by DIBELS and NWEA MAP assessment data. Accelerated growth would help close the gap, especially in the disaggregated subgroups, and result in fewer READ plans in the future. COVID-related circumstances will likely contribute to altered district goals and expectations.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

Barriers include missed instruction and intervention in the classroom setting during the 2019-20 and 2020-21 school years as a result of the COVID-19 school closures and hybrid learning. Although we plan to devote adequate time, teacher expertise, and instructional resources to improve reading outcomes, student reading gaps, especially in disaggregated sub-populations, may have worsened during both years.
