 - Includes scientifically based and reliable assessments and;
 - Provides initial and ongoing analysis of student progress in attaining reading competency

READ Act funds will be used to purchase a core reading instructional program that is included on the Advisory List of instructional programming in reading

- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

READ Act funds will be used to provide other targeted, evidence-based or scientifically based intervention services to students who are receiving instructional services, which services are approved by the department

READ funds will be used to hire a reading interventionist to provide services which are approved by the department

Implementing Allowable Activities

The funds will be used to help pay a salary and benefits for teacher who will deliver reading interventions to students in grades K-3.

The reading interventionist will provide tutoring to students who have been identified as having a significant reading deficiency based on data from NWEA, Dibels, STAR and classroom assessments. The students will then receive interventions by the tutor using SRA Early Intervention in Reading, and SRA Open Court Reading which correlates with classroom reading curriculum. Both programs contain placement and monitoring assessments within them to monitor progress. Each student identified as reading deficient will receive 30 minutes a day on a 4 day week.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

To increase reading proficiency for those students receiving intervention. Program will be monitored periodically through the year to address areas of needs for individual students. The goal is to have each student receiving intervention to be reading at the appropriate grade level at the end of 20-21.

Potential Barriers

Given the uncertainty of the upcoming year one possible barrier could be lack of instruction. Also high poverty is always a barrier. Home outreach, communication, and student on task time are ways in which we strive to lessen this barrier.
