  - Provides initial and ongoing analysis of student progress in attaining reading competency

- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

**READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills**

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

**READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills**

First we will use evidence-based or scientifically-based intervention services for students who are receiving instructional services. We will use the Passport program from Voyager Sopris Learning intervention with our SRD students. This will provide support for students who have not made adequate progress in core reading instruction. We also will provide time for small reading circles with SRD students as well as more in-class reading opportunities

### Outcomes and Goals

**What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?**

We want to see DIBELS adequate gains in reading ability in our identified students within one year, and we want all SRD students to be reading proficiently within 2-3 years. We think this goal is possible based on our small enrollment, which affords us the opportunity the opportunity to work closely with our students.

### Potential Barriers

There is the possibility of remote learning in fall of 2020. because of Covid 19. This would interfere with one-on-one teaching opportunities. We are currently working with health officials on a safe-reopening plan.
