Implementing Allowable Activities

Mesa, Manaugh and Kemper Elementary schools are allocated funding for a reading interventionist (1 FTE/school) to work with K-3 students who have read plans (or at risk of being on read plans). The interventionist works with the student's core instructional staff to provide evidence based reading interventions. Lewis and Pleasant View Elementary schools are allocated funding for a reading coach to work with staff and (K-3) students on a daily basis for a total FTE of 0.3. The reading coach will help to determine who qualifies for a read plan and what evidence based interventions will support students learning.

Mesa, Manaugh and Kemper Elementary schools will also be allocated funds to purchase Lexia "seats" for qualifying K-3 Read act students. Lexia is an approved, supplemental program, to engage students in all aspects of reading and improve reading levels.

Kemper Elementary will utilize the remaining \$3700 for an intensive literacy after school tutoring program in June 2021. The remaining costs for this will be funded through Title V and the other elementary schools are already funded through Title I.

REVISIONS: due to COVID we were not able to hire positions early on, therefore salaries and benefits were not used. Additionally, some staff elected not to take health insurance which greatly impacts our budget. Kemper did not provide after school tutoring due to COVID- so we moved the Kemper funds and Kemper benefits nd Mesa benefits to purchase Wit and Wisdom Geodes for Lewis and Pleasant View elementary schools and to purchase limited Lexia licenses for some of our SRD students in Lewis.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Funding for interventionists will provide at risk students, in grades k-3, the opportunity to get instruction in smaller groups and access grade level reading materials while closing their reading gap. Interventionists will work with small groups of students on Read Plans or at risk of being placed on a read plan, to close

the reading gap through evidence based reading interventions. Our goal for all students, is to increase their reading levels and get them on grade level by the end of 3rd grade (or earlier).

Funding for after school literacy tutoring will increase the amount of time at risk students will have evidence based literacy instruction to help obtain the above goal of getting students reading at grade level or above.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

Potential barriers include, but are not limited to, an increased reading gap due to COVID closures, poor attendance, low parental involvement and understanding of reading importance, and lack of student engagement in the reading process. Our district plan is to have students reading day 1 when they return from being out of school since March. We will need to assess students to pinpoint gaps so that interventionists can begin their work. The district is working on instructional options for 2 week closures or quarantines. If we have to transition to online instruction (for a closure), it will be seamless and we will ensure all students are working with or towards grade level materials. The district has adopted a new reading program and supplemental supports for students- teachers have already received professional development for this transition and will receive more in early fall as well as additional support for a blended learning model.

Increased parental involvement is a district priority, therefore we have funded a parent liaison position to help k-12 schools reach and educate parents on the importance of reading. Elementary schools will dedicate time for parent/student reading evenings, book and materials will be provided from other funding sources. Schools are planning on hosting reading nights beginning immediately when school starts to work with parents on the importance of reading and provide strategies for working at home with their student.

The district's newly adopted reading program, (Witt and Wisdom) along with various supplemental items purchased, will provide evidenced based materials along with engaging student materials.
