 - Provides initial and ongoing analysis of student progress in attaining reading competency

- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

1. Dolores elementary will use Read Act funds to supplement the salary of a reading interventionist for Kindergarten through 3rd grade. This position will support students in their core reading program as well as small group settings. Targeted instruction will be delivered at the students instructional level to move them along the continuum in reading skills. The reading specialist will also support progress monitoring using DIBELS to improve instruction and adapt a students reading plan and goals.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Dolores's expected outcomes are: Increase targeted instruction and reading scores through the use of a state approved intervention and to provide individual targeted small group instruction at the students level with a highly trained reading interventionist.

The use of a targeted evidence-based program for students to access at home or at school will benefit students through most educational restriction that may come as a result of Covid-19.

We expect that there will be a need to closely monitor students returning to school in this unprecedented situation. Having an interventionist who can manage the testing, data collection, and support teachers in goal setting as well as running small group targeted instruction will benefit staff and students.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

Potential barriers: One barrier to this plan may be hiring an interventionist that is capable of the flexibility required for this job, however we have approached a couple of staff that are capable and plan to return in the fall.

Another barrier, given our present circumstances maybe lack of face to face time when utilizing the interventionist. Our district is in the process of planning this scenario for next year through an administrative task force. This task force will plan and prepare for the academic realities of students returning to face to face instruction or a hybrid approach to student learning.
