We are using the Read Act funds of \$1,918.00 allocated to Weldon Valley School District RE-20J to help pay for the Lexia Core 5 supplemental reading program for our elementary school. The total number of students K-6 who have access to the program (licenses) is approximately 116. Per my technology coordinator, an individual license is approximately \$50. According to I-Station, the number of K-3 students reading below grade level is 11. The total number of K-3 students who can access the program is 70. READ Act funds would be used for approximately 38 licenses for K-3 students.

Our goal is with our core reading curriculum and Lexia-Core 5 we will have all our Kindergarten through 3rd grade students reading at grade level or above.

A potential barrier we are concerned with is the loss of direct instruction this last Spring due to COVID-19. We anticipate the additional need of support to help student acclimate back to normal instruction.
