Implementing Allowable Activities

Manzanola Elementary will use READ Act funds to continue to support the districts use of CKLA as the Core reading program. CKLA is a research-based adaptive curriculum that builds mastery of foundational reading skills, vocabulary, and comprehension with activities aligned to each student's reading goals. mCLASS data automatically places students in the program.

In addition, Manzanola Elementary will utilize the time of 2 para-support individuals to tutor students during and after school. Staff members are currently being trained in LETRs.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Through the use of the research-based activities for reading instruction, Manzanola Elementary school will foster the skills needed for a foundational reading program that addresses the necessary components of reading instruction. As a result, aligned assessments will help teachers diagnose reading deficiencies and target specific reading skills for reading success through tutoring.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

Children who read effectively have skills in phonology, phonemic awareness and other abilities related to analyzing the sound properties of words. Accordingly, in an effort to develop effective reading in all children, teachers emphasize the

relationships between the sounds of letters, letter combinations and words. Other reading components occur as the student gains independent strategies for reading comprehension. Reading instruction barriers involves various factors such as background knowledge, vocabulary and fluency, active reading skills and critical thinking that must work together in order for the development of reading.

If a student is not meeting reading goals, Manzanola Elementary will begin to intervene in order to provide needed instructional opportunities for the student. Through the development of a READ Plan and the RTI process, the district will begin to offer Interventions as soon as it is clear the student is lagging behind in the development of skills or knowledge critical to reading growth.

The RTI process will incorporate a team approach to help the student. Teachers will team with instructional para-educator support so interventions can significantly increase the intensity of instruction and practice, which is accomplished primarily by increasing instructional time or reducing size of the instructional group, or doing both. Interventions will be guided by, and responsive to, data on student progress.

Along with the help of a team of teachers and parental support, teachers will meet and revisit student data in order to monitor reading progress.
