During the 2020-21 school year, Fowler School District R4J will utilize READ Act funds to implement tutoring services focusing on increasing the foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for our Kindergarten through 3rd Grade students identified with a significant reading deficiency. The tutor will customize a working plan for our identified students during the school day in both pull-out and push-in fashions. The plan will be coordinated with Intervention teachers, classroom teachers, parents/guardians, and administration and will encompass approximately 200 hours of tutoring time.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

It is our intention to make reading a fun and worthwhile activity for every student and for every student to read at or above their grade-level. The expected outcomes and goals for the 2020-21 school year would be the advancement of all Kindergarten through 3rd grade students identified with significant reading deficiencies to reading at grade level. Understanding that each student is beginning in a unique skill-level, reaching grade-level during the 2020-21 school year might not be attainable but increase by a minimum of one grade-level should be attainable. We will continue to push for every one of our students to be reading at grade-level by the end of their 3rd-grade year.

Potential Barriers

Barriers to reaching our goals in the 2020-21 school year include available face-to-face instruction time with the unknowns surrounding our actual return to school due to the COVID-19 pandemic. Other barriers include the abilities and attendance habits of students, availability of testing opportunities due to the COVID-19 pandemic, and the unknowns surrounding our actual return to school. Additional barriers include student effort, family support, peer influences, etc. We believe that all of these barriers can be addressed and overcome by our tutor working individually with each student and support from teachers, administration, and families.
