- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

Cheraw Elementary students in Kindergarten through 3rd grade already receive reading instruction with Open Court curriculum, which is an approved core curriculum. However, we did not have enough teaching supplies (such as textbooks) last year. With READ ACT funds, officials and teachers would like to purchase enough Open Court textbooks for number of students that we expect to have in class next year so that every student will have access to their own set of Open Court material. We anticipate a cost of around \$2,000.

The remaining READ ACT funds will be used toward the salary of our Reading Interventionist who works with students who struggle with reading in grades Kindergarten through Third.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Cheraw Schools expect elementary students to show growth as measured by local assessments, including DIBELS, STAR reading, and classroom tests. We expect students to score proficient on the 3rd grade state reading assessment.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

The corona virus pandemic is a huge barrier to overcome. Cheraw Schools is pushing an in-person experience, which should provide better educational experience than on-line. Officials of Cheraw Elementary School have also

purchased (with other funds) Chromebooks for each student to use in class and at home, in-class and online reading curriculum, webcams and audio equipment to enhance the electronic needs for education this year, new laptop for the teacher, and increased training for teachers to provide better instruction through a blended environment.
