 - Provides initial and ongoing analysis of student progress in attaining reading competency

READ Act funds will be used to purchase a core reading instructional program that is included on the Advisory List of instructional programming in reading

- READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

READ Act funds will be used to provide other targeted, evidence-based or scientifically based intervention services to students who are receiving instructional services, which services are approved by the department

Ouray R-1 will continue with Summer School Program which targets students on a READ plan or with low reading skills. Our Title I Teacher and 2nd Grade Teacher, both of whom have had LETRS training, will work with these students.

Ouray R-1 continues to employ a full-time Title I Teacher who has had LETRS training and has attended the READ conference during the 19-20 school year. It has been canceled and/or postponed for the 20-21 school year but we will make this available to her when available.

Ouray R-1 will fund new teachers to Ouray with the online LETRS training modules and accompanying workbooks.

Outcomes and Goals

Ouray R-1 feels fortunate to employ a full-time Title I teacher. She works with students either in very small group settings or one-on-one, due to our small enrollment numbers. This summer we will implement and continue a reading based Summer School Program targeted for students on a READ plan.

All of our elementary level teachers have done the online LETRS training and funds are available to train new elementary hires.
