Platte Canyon School District will continue to utilize our money to fund a part-time READ teacher that specializes in reading interventions for our k-3 students at Deer Creek Elementary. This teacher will provide scientifically-based interventions to all students who qualify for READ services. These interventions will be intensive in nature and focus on closing identified reading gaps. These interventions will be provided in addition to reading instruction that all students receive in the general education classroom. Students are identified and monitored through the bi-weekly use of Dibels. The interventionist utilizes Really Great Reading programs, Orton Gillingham, and Haggerty at grades k-3 to support student learning and close the gap.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

According to Deer Creek Elementary's UIP, k-2 teachers will implement strategies from Orton Gillingham to improve structured phonics instruction. Deer Creek has also established an intervention schedule that provides for 45 minutes each day for tier 2 intervention strategies with teachers as well as special service providers. Their overall goal is for students to demonstrate improved phonemic awards and reading strategies, as well as overall reading skills.

Potential Barriers

What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

Barriers in reaching these goals would include a continued at home order for learning. We will continue to address these concerns with individualized

instructional video meetings with students to support the continued growth of all students, especially those identified with a significant reading deficit. Another potential barrier is the lack of enough specially trained teachers to provide the necessary intervention. READ funding allows for another reading teacher for the building to support smaller group instruction with more individualized supports.
