The summer school literacy program will use scientifically based or evidence based instructional programming in reading that:

- Has been proven to accelerate student reading progress and;
- Provides explicit and systematic skill development in phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension and;
- Includes scientifically based and reliable assessments and;
- Provides initial and ongoing analysis of student progress in attaining reading competency

READ Act funds will be used to purchase a core reading instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase a supplemental instructional program that is included on the Advisory List of instructional programming in reading

READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

READ Act funds will be used to provide other targeted, evidence-based or scientifically based intervention services to students who are receiving instructional services, which services are approved by the department

READ funds will be used to hire a reading interventionist to provide services which are approved by the department

Implementing Allowable Activities

Telluride Elementary School "TES" will run a three week summer school for students identified as having an SRD. If there's space, TES will include other students that are performing below grade level proficiencies in literacy. This will include paying three core teachers at the rate of \$40 per hour, plus paying additional part-time teachers for extra support to bring down the teacher/student ratio during interventions.

TES will replenish supplies (consumable workbooks, teachers' guides, etc.) as needed for Reading Mastery intervention programming in grades K-3.

TES will also offer an after school tutoring program for students in grades K-2 that have been identified as SRD and, as space allows, for any other students that are performing below grade level expectations in literacy. Two teachers will be paid \$40/hour. This program will run two days per week from 3:15-4:15.

READ Funds will be used to purchase iReady reading licenses for students in grades K-3.

Year end update - As a result of COVID-19 the tutoring programs were not offered during the year, however, summer school is in progress. Instead TES will use these funds for Orton-Gilliamham training for our five teachers that also work as reading interventionists and coaches.

Outcomes and Goals

Our TES goal is to assist all of our students in achieving grade level proficiencies in literacy and to develop the skills necessary for success in the future.

With the unexpected interruption in face-to-face learning due to Covid-19, TES will determine how a potential learning gap plays out for our students. We plan to assess these learning gaps as comprehensively as possible and then adjust curriculum as needed. Our team will be ready to implement an “all hands on deck” approach in terms of planning, scheduling, and supporting our students and their families during this unprecedented time.
