READ Act funds will be used to purchase tutoring services focused on increasing students' foundational reading skills

- The tutoring service is focused on increasing students' foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skills, and reading comprehension for students who receive instructional services pursuant to READ plans

READ Act funds will be used to purchase from a BOCES the services of a reading specialist or reading interventionist who is trained in the science of reading and in teaching the foundational reading skills

Summit School District is choosing to use the READ Act funds to provide professional development through the hiring of a 1.0 K-3 Literacy Coach. The coach trained in Orton-Gillingham and the Science of Teaching Reading will be supporting teachers within the confines of evidence-based reading strategies and processes. The coach will oversee the new CDE approved program selected by our Literacy Committee fall 2021. The coach will work to ensure teachers are understanding and implementing our new materials.

In addition, READ Act funds will be supporting a portion (0.2) of our K-12 Literacy Coordinator. The Literacy Coordinator will be working closely with the K-3 Literacy Coach on leading the K-3 Literacy Committee on the selection of materials and follow-through in utilization of these materials.

SSD has 53,422 in remaining funds for 2020-2021. These will support our new core literacy curriculum, Wonders (McGraw Hill) . We will put \$35,422.00 towards the core programming which is a CDE approved curriculum.

SSD will use the remaining \$18,000.00 towards training classroom and Tier II intervention teachers with Yoshimoto Orton-Gillingham training. We will be using this as a support in knowledge for the classroom teacher and as one of our Tier II interventions for the district.

Outcomes and Goals

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

Expected Outcomes:

1) We will see staff increasing knowledge on how to utilize the Science of Teaching Reading through new core Wonders materials and coaching sessions with the K-3 Literacy Coach and Literacy Coordinator.

2) We will see an increase in accountability in utilizing the district and CDE approved program and materials to teach reading in K-3, due to the active monitoring from the K-3 Literacy Coach and Literacy Coordinator.

3) Teachers will find success and desire through learning how to analyze teaching behaviors to increase student performance in the program.

4) We will see an increase in student's reading scores on FAST, NWEA, and CMAS.

Potential Barriers
