Implementing Allowable Activities

The Weld Re-8 School district intends to employ a Reading Interventionist at both of our K-5 Elementary Schools (Both are also Title I schools) and at our PK-8 School. These reading interventionists will work with elementary students on READ plans to enhance their instruction. Interventionists will work with small groups and align instruction to supplement what the students are learning in the home classroom. READ Act funds are budgeted to supplement approximately 50% of each of these three positions, for a total of 1.42 FTE in the district.

Reading Interventionists will work with students from all grades in their school, but in each school, over 75% of the applicable students are in grades Kindergartenthird, so the READ Act funding will go towards directly supporting students in these grades on READ plans. Reading Interventionists will use the ReadyGen program to work in sessions with students in the same grade level, totaling approximately 60 -70 students in grades Kg-3 at each school and including all students on READ plans. These students will meet in small groups of 5-8 students for sessions totaling approximately 1.5-2 hours each school week.

#### **Outcomes and Goals**

What are your LEP's expected outcomes and goals in the upcoming budget year from implementing your selected allowable activity(ies)?

The Inclusion of Reading Interventionists at the elementary level will enhance the instruction for students on READ plans and allow for individualized differentiation of grade-level material. The intention, of course, is that all students on READ plans will grow at a higher rate and no longer require the plans. Our goal is to reduce the number of students on READ plans by 20% in each grade level at each school while ideally also reducing the total newly identified students in the spring of 2021 by 10% compared with the 2020 baseline.

# What are potential barriers in reaching your expected outcomes and goals? How do you plan to address and/or overcome these barriers?

This year the change to distance learning was a huge setback to instruction. We are preparing for the 2020-21 school year with the intention that coaches and interventionists will need to be agile and ready to respond to an online learning environment if needed. We also have a high percentage of English Language Learners (over 50% in some schools) and are working to integrate ELD Specialist and Reading Interventionist services so that student get the support they need while not missing out on the core instruction.
