District: Summer Academy: Denver Public Schools leveraged the funds provided to us through the READ Act to continue implementing the DPS Summer Academy program in Summer of 2021. This program, targeted at students who are significantly below grade level and below grade level based on either their fall or mid-year READ assessments, is dedicated to ensuring each and every DPS student has the supplemental instruction to accelerate their learning towards being at grade level and to avoid the summer learning slide. The DPS Summer Academy will be leveraging high performing teachers, a focused professional learning program, and a research driven curriculum from CDE's Advisory list to meet this goal. We have used previous funds to purchase two CDE approved curriculum (95% Group for ELA-E and Esperanza for ELA-S); we have worked with Anji Gallanos to ensure all supports for our ELA-S students are in alignment with READ Act specifications. Given that we will be continuing our work with updated curricular resources, we have built in additional planning time into our teachers' schedules and will be providing targeted Professional Learning in early literacy instruction. The Summer Academy program operates over an approximately four-week period during the summer soon after the last day of school. Important to note that Summer Academy was materially changed in design in for Summer 2022. The read act dollars were used for the old Summer Academy design that was developed with Anji Gallanos. Core Reading Instructional Program: In addition to using funds to operate Summer Academy, we will be purchasing core curriculum for use in K-2 classrooms during the school year to support Science of Reading aligned instruction. Estimated FY20-21 approved carryforward (\$1,518,092.86) As of June 2022 we have \$2,986,559 in remaining funds that we would like to request in carryforward. The district committed to purchasing \$8M of curriculum for CKLA which will be expensed in July 2022. This curriculum will support K-3 classrooms in the FY23 school year. Charter School: 187 - STRIVE Ruby Hill 0880 - 8401:At STRIVE Prep - Ruby Hill, we plan to utilize READ Act funding to continue building out the approved curricula in use at our school, including CKLA and EL, both used for core instruction, as well as elements from 95% group, Really Great Reading, 95% group and Istation. To lead the implementation of these curricula, to train staff and provide ongoing coaching, we will work with outside presenters from some of these groups, send staff to appropriate trianings and dedicate time for our Special Education Chair and MTSS Coordinator to support the school's implementation of these resources. Charter School: 212 - Wyatt 0880 - 9739: Our school has implemented the use of Amplify CKLA as part of the core literacy in our daily literacy block for all K-3 grade classrooms. Students all have the opportunity to participate in the curriculum with appropriate differentiation as needed. Our school has also utilized the SIPPS curriculum as part of our intervention programming for struggling readers in K-3 grades. Interventionists were trained to use the SIPPS programming and progress monitoring tools to support filling in reading gaps in phonics, phonological awareness and sight words with this curriculum in a small group on

a daily basis. Programs: Amplify CKLA, and Reading Interventionist using either Amplify CKLA or SIPPS CHARTER-0880 - 6957 - 309 UNIVERSITY PREP - STEELE ST: Along with the purchase of CKLA curriculum and Wit and Wisdom curriculum, we are training teachers on how to use these curriculum. Each teacher has a designated coach that also provides curriculum implementation feedback on a weekly basis. CHARTER-0880 - 8945 - 168 UNIVERSITY PREP: Along with the purchase of CKLA curriculum and Wit and Wisdom curriculum, we are training teachers on how to use these curriculum. Each teacher has a designated coach that also provides curriculum implementation feedback on a weekly basis. "Charter School: 175 - SOAR GVR: We use the i-Ready Diagnostic Assessment for identification and monitoring of students with a Significant Reading Deficiency. The detailed reports teachers get from these Diagnostic Assessments are used to help focus instruction for students, small groups, and the whole class. With the support of our literacy coaches, teachers are able to plan next steps for daily instruction from these results. Between Diagnostic Assessments students engage in i-Ready Instruction set to meet their individual needs. Early Literacy Professional Development: Kindergarten through Third Grade teachers systematically engage in scientifically and evidenced based literacy development each week with our literacy coaches (Kristin Hahn & Michelle Barone). These sessions are focused on developing teacher's skills, knowledge, and expertise in scientific and evidenced based early literacy practices. They allow teachers to development new teaching techniques and dig into new educational research on how best to meet the needs of their diverse learners. Early Literacy Coaching: Our highly skilled literacy coaches provide observation and feedback to kindergarten through third grade teachers. Coaching is focused on evidenced based practices that teachers have learn through professional development sessions. Coaches give feedback and support teachers to implement these practices and to meet the needs of individual learners. Charter School: 192 - REACH: READ Act Funds will be used to pay for READ Act approved assessment in literacy. READ Act funds will be used to support special education staffing to support K-2 READ Act expectations to provide targeted, evidence-based intervention services to students. CHARTER-0880 - 6508 - 196 OMAR D BLAIR CHARTER SCHOOL: I-Ready will be implemented in the following ways to support evidence-based intervention services: 1) it will be used as a universal screener to identify students who may be diagnosed with a significant reading deficiency, it will be used as a leveled instructional reading intervention delivery tool, and it will be used as a progress monitor to track student growth as a response to intervention. We will be able to use this system in both a remote and in-person instructional environment, by assigning lessons and assessments at their level. This will be used by both the reading interventionist and reading paraprofessional Charter School: 211- Odyssey 0880 - 6479: Odyssey will use its Read Act funds to provide targeted, approved, evidence-based intervention services through the work of a .5 Reading Interventionist. This staff member has received basic and advanced training in the Orton Gillingham method, an intervention program that offers LEPs with explicit instruction in phonological and phonemic awareness, Phonics and Word Study, Vocabulary and Text Reading Fluency. This interventionist will use iready diagnostic and progress monitoring data as well as assessments found in the EL Education program that all K-2 students are provided (an approved READ Act core program) to work through the OG scope and sequence and support students with lots of practice and repetition to learn the foundational aspects of reading. Charter School: 161- Monarch Montessori 0880 - 5621: We will use these funds to support a portion of the pay of a full time reading interventionist, who will use researchbased approaches to reading intervention with Tier 2 and Tier 3 students. Further, she will support coaching of teachers as needed, and provide leadership in our MTSS approaches and meeting. Charter School: 316- KIPP SUNSHINE PEAK ES: As part of our biliteracy model, students will engage with skills and strategy lessons and guided reading lessons using paired texts from our curriculum in Spanish and English. This is part of the larger vision for literacy instruction that includes interactive read alouds, shared reading and reading workshop, small group literacy instruction, buddy reading, and phonics. KPSE will be using the vendor Curriculum Associates (i-Ready) to support

the below budget description and to further its use of evidence based reading instruction. Charter School- 306- KIPP NE ES 0880 - 4500: Our interventionists are essential to responding to the academic and behavioral needs of students who are not meeting outcomes given effective tier one instruction. The interventionist position implements a rigorous screening and identification process that invests teachers in collecting precise data for all the students in their class. 6 week cycles of interventions are carefully put into place after the interventionist has had repeated contact and an in person meeting with the student's family and teachers. The interventions are progress monitored on a weekly and daily basis to determine their effective across multiple points of both quantitative and qualitative data. The goal is to move as quickly as possible to the least invasive intervention the student requires to achieve grade level success. The interventionist also monitors the implementation and quality execution of tier 2 and 3 curricula. This programming is focused on: phonemic awareness; phonics; vocabulary development; and reading fluency, which includes mastery of oral skills and reading comprehension. It utilizes approved literacy curriculums including Foundations, Engage NY, Marivella, and Better Immersion. In addition, students' literacy skills with be assessed at the beginning and the end of the Summer School Literacy Program using normed assessment tools to ensure student growth and to identify specific areas for improvement. A sample day in the Summer School Literacy Program is from 8:00 am - 11:30 am, and includes 2.5 hours of literacy instruction and support (one hour and twenty minutes of foundational literacy, including reading and language practice, and one hour and ten minutes of writing and listening). Students also have time for recess and snack breaks. All the Summer School teachers are highly skilled in teaching foundational literacy, writing, and listening skills, as well as in administering and interpreting assessments. These funds will provide approximately 5 of our summer school teachers a \$1200 stipend. As a full immersion elementary school, we have an agreement with CDE to use the Better Immersion curriculum for our Mandarian program as we do not instruct in English in our early elementary grades (K-2). The use of other curriculums listed in our grant narrative submission (Foundations, Engage NY, Maravillas) are all approved READ Act curriculum and advisory materials. Charter School: 182 -DDES 0880 - 2207: The Downtown Denver Expeditionary School will be using READ Act funds to employ a reading interventionist who will provide targeted evidence-based reading interventions to students who are receiving instructional services approved by the department in both push in and pull out format.. Charter Academy 360: Our Director of Lower Elementary Academics is a trained Reading Interventionist. She will use the Voyagers Passport Program, alongside Istation's blended learning curriculum, to conduct intervention for Tier II and Tier III students, including those with Read Act plans. Additionally, 1/10 of her time will be coaching other teachers conducting small group

reading interventions also using the Voyagers Passport Program. Both of these are allowable expenses per CDE.
