The selected allowable activities will be implemented as: *Wonders Reading curriculum will be implemented in grade k. The curriculum has already been purchased for the entire elementary. Because we are adding a second kindergarten class due to an increase in enrollment for 2021-2022 (originally our district planned for 1 kindergarten class for 2021-2022), funds will be used to purchase the required curriculum for this class. *Really Good Reading/Blast and Countdown will be utilized by Calhan Elementary's reading interventionist as well as the SPED teacher as a supplemental program in grades K-3 with a heaving emphasis in grades k and 1 for students with an identified SRD. These programs will be used in a small group setting. *Training for Blast will be provided for 2 reading and sped paraprofessionals as well as 1 first and 1 second grade teachers. These individuals will be working with students identified with a SRD in grades k-3. Instruction will be delivered in a small group setting. *Materials required for effective Blast implementation provided by the reading and sped paraprofessionals and 1st and 2nd grade teachers will be purchased. *Reading interventionist/SPED online Blast/Countdown curriculum will be utilized in a small group setting for students with an identified SRD.
