Cheyenne Mountain School District has a staffing formula which includes Learning Interventionists at each of our elementary schools to provide targeted, research based instruction to students on READ and MTSS plans. The role of the Interventionist is to provide individual and small group instruction for students who have a significant reading deficiency and assist them to become on level readers. Early intervention in grades K-3 (READ) is the primary focus for these interventionists. Programs include: SIPPS, Heggerty Phonemic Awareness Primary Curriculum, HillRap, Orton Gillingham -Yoshimoto Orton Gillingham, and Lexia - Core 5 Reading. READ funds support salary and benefits for one of the five interventionists.
