TSD will use READ funds to pay for a Literacy Specialist who will support teachers with READ plan creation and appropriate interventions. The Literacy Specialist will also support teachers as they are trained on the Science of Reading and implementation of this learning. TSD will also use the funds to purchase Fundations (a CDE approved supplemental program) for all K-2 teachers and half of the 3rd grade teachers. With the materials, TSD will also ensure that each teacher is trained on the materials and how to utilize these to positively impact literacy for all K-2 students. Because we have to split the training times up, we will need funds to pay for subs and extra hours for some of the teachers needing training. TSD will also be purchasing Geodes, Fundations Decodable Libraries, to support the implementation of the materials as well as the Science of Reading. TSD will continue to provide Lexia and iReady licenses for K-3 teachers. To build on the Science of Reading training and literacy focus for the district, TSD will be sending instructional coaches and interventionists to the CCIRA conference in February to increase their literacy background and give them learning and resources that they can bring back to their buildings to support all teachers through training and coaching.
