Limon Elementary has identified a phonic weakness in our core reading program. To address this, Limon Elementary will continue with the phonics intervention program, 95% Group. To assist the instructional staff, Limon Elementary will utilized Read Act dollars to provide online professional development trainings in the areas of dyslexia, phonics and phonological awareness, along with support utilizing multisyllable routine cards. Additionally, Read Act funds were used to purchase the Acadience Reading Interim Assessment program. This program allows Limon Elementary students to be benchmarked three times a school year and also progress monitored.
