Dolores Elementary will use Read Act funds to supplement the salary for a reading specialist who is highly trained in reading interventions and the 5 components of reading. This reading specialist will oversee the training of new paraprofessional staff in preparation to support interventions in the classroom. The reading specialist will monitor our DIBELS benchmark process and make sure all student's progress is monitored according to the state guidelines. The reading interventionist will meet with students, delivering targeted instruction of the 5 components of reading to achieve grade-level reading skills. The reading interventionist will report the progress of students to the classroom teacher and the Title 1 teacher. In this way, students will be monitored through differentiated instruction in the classroom and additional interventions if necessary.
