During the 21-22 school year, Fowler School District R4J will utilize READ Act fund to implement tutoring services (licensed teacher and mClass Amplify) focusing on increasing the foundational reading skills of phonemic awareness, phonics, vocabulary development, reading fluency including oral skill and reading comprehension for our Kindergarten through 3rd-grade students identified with a significant reading deficiency. The tutor will be a Licensed Teacher and will customize a working plan for our identified students during the school day utilizing both pull-out and push-in strategies. The plan will be coordinated with the Intervention Teachers, Classroom Teachers, Parents/Guardians, and Administration and will encompass approximately 75 hours of tutoring time.
