The interventionist provides Tier 2 and 3 interventions that increase time and intensity of instruction using Linda Mood Bell for Tier 3 support and 95% group and SIPPS for Tier 2 students. The interventionist also conducts ongoing DIBELs monitoring, and designs supports for the classroom teacher to continue to develop reading skills.
