She is Orton-Gillingham trained and supporting our O-G trained teachers in the elementary buildings. In addition, READ Act funds will be supporting .2 of our K-12 Literacy Coordinator. The Literacy Coordinator will work closely with the K-3 Literacy Coach in elementary buildings and planning the professional learning needed to grow understanding of the Science of Teaching Reading and our new literacy materials.
