READ Act funds will provide a full-time district-level reading coach who is trained in the foundational reading skills to provide job-embedded, ongoing professional development to the K-3 teachers in Englewood's four elementary schools. This will include on-site support to individual classroom teachers, work with instructional coaches, and professional development for school sites. The district-level reading coach will provide job-embedded support to general and special education teachers, interventionists, and instructional coaches. The job-embedded support will come in the form of collaborative planning, instructional modeling for teachers, and observation/feedback. Additionally, the district-level reading coach will provide all necessary professional development required for READ Act. This includes all training for utilizing Acadience benchmarking and progress monitoring. The necessary professional development for utilizing the Amplify system for data collection and all the necessary training for writing and implementing effective READ Plans. The district-level reading coach will have monthly ongoing professional development with the district reading interventionists designed around the science of reading, teaching foundational reading skills, and research and evidence-based interventions. The district reading coach will also have after-school professional development opportunities for job alike teachers to work collaboratively around planning their Skills Block lessons from EL Education as well as professional learning with the science of reading and best practices for all K-3 teachers.
