Our summer school teacher uses Amplify-mCLASS Reading Edition Kindergarten and First Grade All Components to target student gaps and offer explicit instruction to fill in those gaps. 2) We provide other targeted, scientific, or evidence based intervention services approved by CDE: A) Our district budgets to help fund a certified reading intervention teacher trained in providing explicit and targeted interventions to students identified with an SRD. B) Intervention materials are also purchased to provide intervention services such as Amplify-mCLASS Reading Edition, the Haggerty Phonemic, Orton Gillingham-Yoshimoto Orton Gillingham Phonological & Phonemic Awareness, and Phonics & Word Study Awareness Curriculum. 3) Technology A) Amplify-mCLASS Reading Edition. B)Lexia-Core 5 Reading Phonological & Phonemic Awareness (early & basic levels), Vocabulary, Phonics & Word Study (advanced level), Vocabulary, Listening Comprehension and Text Reading Fluency.
