Both of our elementary schools have shifted to an experiential learning model this year. We have purchased LearnZillion as well as EL modules. Additionally, we will utilize small group differentiated instruction based on student needs, which will be assessed and monitored consistently. We will utilize reading tutor hours this year, structured to meet student needs based on data. We will continue to use Lexia as a supplemental resource. Further, we are continuing to train teachers in Orton Gillingham (some are already trained) so that we have all K-2 (and possibly K-3) teachers trained and able to use this supplemental resource/tool with students.
