The read act funds will be used to purchase the Istation programming which includes intervention instruction for each individual student and the assessment needed for benchmark testing and progress monitoring. The license will cover 138 students in grades Kindergarten through 3rd grade. The remainder of the funds will be used to purchase the STAR assessment for the 138 students. The remaining funds will not cover all the licenses for the STAR assessment, so general funds will be used to supplement the cost. We have been using the Istation and STAR for our assessments for the past few years and feel the information teachers receive is valuable in understanding what students know and what gaps they currently have in reading. The Istation was not chosen as one of the approved ELAT assessments, so we are using READ act funds to purchase the assessment we feel is beneficial for students and teachers.
