The district intends to use our READ funds in four (4) specific ways: 1. Purchase Core Instructional Programming: We will use READ funds to purchase the necessary student materials that correspond with the Core Knowledge Language Arts (CKLA) curriculum for K-3. CKLA is approved for all grade levels as a research-based reading curriculum, and there are annual costs associated with its implementation. 2. Strengthen Core Instructional Programming: Provide professional development to K-3 teachers to strengthen their implementation of our approved Core Instructional Program, CKLA. 3. Strengthen Intervention Supports: Purchase software access to iStation to provide intervention support for our students testing in yellow and red. 4. Provide Professional Development: We will hire a reading coach/interventionist position to support teachers in collecting, analyzing, interpreting, and applying data to make intervention and instructional decisions to support students improve their reading proficiency.
