The funds requested will be used in order to meet the needs of 7th Street Elementary with the intention of reducing the number of students with an SRD within our educational system. Our LEP has worked diligently to reduce the number of SRD students and so far has done a good job. We credit the implementation of a new core reading program in 2019, our teachers taking the LETRS professional development course on the science of teaching reading, purchasing the Really Great Reading intervention for our MTSS program, and utilizing Lexia Core 5 as a supplemental program. Additionally, our teachers are using Haggerty within their programming to help with phonemic awareness. For this upcoming school year, we feel that we need to utilize the funds to continue the purchase of Lexia Core 5 and to help pay salaries for individuals supporting our MTSS program and providing interventions for students with an identified SRD. Both purchases are identified as acceptable uses of funds and Lexia Core 5 is on the CDE program advisory list. We also feel it is important to continue implementing our core reading program, LETRS, and Really Great Reading. In the future, we plan on spending our funds on continuing professional development for new teachers entering our building to learn the science of teaching reading by starting a second cohort of LETRS trainees. It is the feeling of the administration that our success has been rooted in these implementations and now it is our job to continue that success by providing the means for a learning continuum among our new and veteran staff.
