Due to inconsistent achievement and growth trends and due to the continued effects of COVID, our instructional leadership team determined that we need to continue to support the implementation of our core literacy curriculum, provide training, coaching and professional development, along with reading intervention services for students on READ plans, using READ dollars to reduce the number of students we have on READ plans. Monument Charter Academy, Bear Creek Elementary, Kilmer Elementary, Palmer Lake Elementary, Prairie Winds Elementary and Lewis-Palmer Elementary will use \$ respectively toward the salary of Reading Intervention Teachers. Palmer Lake Elementary will also use some funds for after school reading tutoring using evidence-based and approved resources. Monument Charter Academy also requests to use a small amount of funds for READ materials and supplies (\$1735.27) We are allocating our \$5,000 carryover towards providing Orton-Gillingham training for staff at Bear Creek Elementary.
