BES has seen some success with teachers implementing Heggerty in small groups in the classroom. We've decided to start this initiative as a tier 1 phonemic awareness instruction beginning with preschool. The team received training on Heggerty in order to implement this program at the tier 1 level next year. Heggerty materials were also purchased. 95% group phonological awareness kits were purchased and trained on in the past year for use with Tier 2 intervention. Purchased some 95% Vocab Surge Materials to better teach vocabulary in 3rd grade Offset rising cost of the imagine learning programming the school has been using as a supplemental reading instruction and data source. Purchased IMSE OG training for a lead staff member who has this training, but requested a training in order to stay abreast of newest strategies .
