This comprehensive phonics and word study program will help close phonic skill gaps during our summer school program. Specific skills addressed are: phonemic awareness, alphabetic principles, word attack skills, reading fluency and comprehension. Additionally, 95% core program, a CDE approved supplemental program, will utilize Read Act dollars to purchase student a teacher core resources. Read Act funds were used to purchase the iStation Assessment program. This program allows Limon Elementary students to be benchmarked three times a school year and also progress monitored. Read Act dollars were used to purchase additional supplies for 2nd grade students. Wonders core reading program is utilized by Limon Elementary students.
