A major portion of our budget is for Summer School to improve student growth in reading competency. 1. Summer School: Our three-week Summer School includes: - 100 students - student transportation - 20 teachers - data-driven instruction - flexible grouping based on growth/achievement 2, Core Reading: The District purchases additional materials such as LETRS, FAST, BLAST, FOUNDATIONS, PALS, and NWEA to maximize growth/achievement of all students. All materials are on the Advisory List of Programming. 3. Other Services: RE-1 Valley uses READ funds to partially fund K-3 literacy coaches and instructional materials to assure student growth/achievement in all classrooms.
