D51 plans to serve our K-3 students who are on a READ Plan with interventions Lexia, 95% Group, and SIPPS. Each school will have a trained paraprofessional to support the student and teacher in implementing and monitoring these interventions. D51 will contract with STRIVE to provide explicit professional learning around supporting teachers in understanding DIBELS READ Act data, intervention matching, and progress monitoring of reading skill development. D51 Charter School Juniper Ridge will implement Orton Gillingham's intervention and have a Reading Interventionist to support staff and students in implementation. Charter School Mesa Valley Community School will utilize Lexia Core5 intervention with K-3 students on READ Plans and Independence Charter school will implement mCLASS intervention.
