The district plans to implement summer literacy camp through Scholastic with Students who are identified and qualify for services. The Scholastic resources are aligned with the Wonders Core Reading Program, which provides leveled reading and support. In similar fashion, qualifying students will have access to tutoring sessions with teachers as well. The tutoring will consist of double dose time to work on basic reading skills and fundamentals. The district will utilize the funds to purchase allowable assessments to diagnose and progress monitor students as well. DIBELS is used as our assessment tool to progress monitor our students. The cost of the summer program teachers utilized all of the funding so the supplies were purchased with a different grant to support the program.
