Manzanola School District will use READ Act funds at the elementary level (grades K-3) to continue to support the district use of CKLA as the core reading program. CKLA is a research-based adaptive curriculum that builds mastery of foundational reading skills, vocabulary and comprehension with activities aligned to each student's reading goals. mCLASS data automatically places students in the program. In addition, staff at the elementary level in grades K-3 will utilize one or more paraprofessionals to tutor students during and after school. Elementary staff have been trained in the LETRS program.
