Our district is offering LETRS training to staff to meet the Read Act Teacher Training requirements. Our core instruction includes Great Minds' Wit and Wisdom, Foundations, and Geodes. We have used Lexia Core 5 as a supplement to our core instruction for K-4. We use Wilson Foundations, Wilson Just Words, and Wilson Reading System for intervention instruction. We use Heggerty Phonemic Awareness instruction as a core supplement. We use read act funds for supplemental tools like decodable readers and supplemental Wilson foundations and Wit and Wisdom materials as tools for both general and intervention staff.
