These funds will be used to help the district will maintain a full-time reading interventionist to work with K-3 students using targeted reading interventions as detailed in our Literacy Action Plan. Students who are below proficient in reading need additional time and intensity matched to the student need(s), which involves more time daily, above and beyond 90+ minutes of universal instruction focused on the specific needs of the student as identified by diagnostic measures. Instruction can be intensified in three ways: (1) more time, (2) more targeted instruction, (3) smaller group size. The interventionist will help to group students and provide intervention programming focused on needs identified through diagnostic measures: assess the literacy development of K-3 students in phonics, vocabulary, fluency, comprehension, and oral skills. The reading interventionist will provide small group and 1:1 targeted support for students with SRD. The increased time and intensity, coupled with approved interventions including SIPPS, SPIRE, Orton Gillingham, 95% Group, and Lindamood Bell as appropriate for specific needs, provide the necessary support for identified students.
