Telluride Elementary School offers four weeks of summer school to students entering 1st through 3rd grade during the months of June and July. These students are selected based upon their need for reading intervention based upon iReady diagnostic scores. After school tutoring will also take place for students in grades K-3 to help them to achieve needed literacy skills. Existing teachers will be paid for these extra hours at their contracted rate, plus associated taxes and Pera Contributions. The teachers are sometimes supported by a paraprofessional. The district utilizes iReady assessment and instructional programs and a portion of that cost for k-3 is paid for through the READ Act grant. The district also uses these evidence based reading instruction, intervention and supplemental tools: Wonders (2023), Maravillas (2020), Raz Plus and iStation. BUDGET REVISION: With the reduction in READ Act grant, the entire allocation will be spent on after school tutoring offered 4 days/week throughout the year.
