Implementing Allowable Activities

In order to best support our youngest learners in the area of literacy, we plan to utilize our READ Budget toward our summer reading intervention program (funds will be used to pay the summer interventionist). This intervention is designed to assist with students in need of catching up, maintaining what was gained over the course of the school year as well as front-loading students with the necessary information and skills to begin the next school year successfully. Groups will be no more than 3-5 students. Depending on the group of students, the summer interventionist will implement interventions that include the following resources with fidelity: Heggerty, 95% Phonics, Reading Mastery (for tier 3 students in need of catching up) and use of Into Reading in order to review or front-load information for the next school year. The summer intervention program will take place during the months of June, July and August for one and a half hours per day 4 days per week. We also plan to use Title funds to purchase the iReady tool which will be utilized throughout the school year as a classroom intervention K-3rd which will specifically meet the needs of the students following the benchmark assessment and will be used throughout the summer intervention. Based on the benchmark and diagnostic assessments through the use of iReady, teachers will implement and students will have access to the iReady personalized instruction a minimum of 45 minutes per week in reading in addition to their core instruction and any additional support needed. Teachers will utilize data and meet with students individually to identify goals and plan for student growth and achievement.
