The remaining portion of funds will be used to supplement an Instructional Coaches salary who will focus on working directly with teachers to implement CKLA core curriculum in grades K-3. Cardinal Community Academy (CCA) will use their portion of READ funds to supplement a Reading Interventionist salary who will provide other targeted, scientifically or evidence-based intervention services which are approved by CDE.
